

Terms and conditions of Best Price Guarantee in Euronics retail stores

- Best Price Guarantee is valid for registered Euronics loyal customers.
- Best Price Guarantee applies only to retail stores operating under the name Euronics (Antista AS, Metaan AS, Võru Polar OÜ and Coop Põlva TÜ).
- Best Price Guarantee is based on an identical product code specified by the manufacturer (product code, article code, GTIN code, model code, SKU, PN, MPN and another unique code specific to a specific product). If the product code is not listed in the competitive offer or there is a disagreement on product identification, we may ask you to send us other parameters that confirm the product identity, such as name, model, series, appearance, completeness, specification, sales area and GTIN code (EAN barcode).
- Best Price Guarantee is based on the goods actually available at the competitor. For ordered and finished products, the service does not extend.
- Best Price Guarantee applies once for each product/transaction.
- Best Price Guarantee does not apply to offers on the Internet, including goods purchased from Euronics online store (www.euronics.ee), special offers from Euronics stores, promotional campaigns and third-party special offers. .
- Best Price Guarantee does not extend to offers related to subscription and fixed-term contracts and offers with added value or gifts. Also, Best Price Guarantee does not extend to a competitor's limited quantity offers, samples, products returned by the customer, used products, hire-purchase offers, gifts, mispricing and coupon offers.
- Only Estonian competitor's (legal entities registered in Estonia) leaflets, advertisements published in newspapers/magazines or other acceptable evidence are evidence of the Best Price Guarantee.
- To compensate for the price difference in the Best Price Guarantee, the customer must present a document certifying the purchase from an Euronics store, i.e. a receipt.
- Best Price Guarantee applies to all products sold in Euronics stores (Best Price Guarantee does not apply to the prices of services).
- The price difference for Best Price Guarantee will be refunded to legal persons after making the purchase on the basis of the application. The price difference is calculated on sales prices excluding VAT.
